New functioning of the

Strictly Protected Area of the Medes Islands

We inform you of the change in the planning and organization of the Medas Islands marine nature reserve, as of 2015 moving from a general limitation of the diving places per day to an annual limitation of the places with a different amount of places for each buoy.

We inform you of this change so that you know the new functioning and because we believe it is good that the public knows the status of the ecosystem of the Medas Islands. In this way everybody can help protect the area by diving more accurately andtogether, reduce our impact when we are in this marine environment.

Until now the limitation was daily, with a maximum of 396 allowed dives per day, in total for the diving centers with license to operate at the Medas.

From this year this has been reduced and changedto adjust to the results of the completed biologic studies and of future monitoring

74.224 dives / yearto distribute between all the licensed centers

Why is this change? The current management model was drawn up in 2008 for a duration of 4 years extendable, considering that the planning andmanagement of the Nature Park should continuously be reviewed to be able to adapt to the changing needs of its visitors and their relation with the natural environment of the Park.

Change how? Biological monitoring has been carried out to study the impact of scuba diving at the Medas Islands and it has been concluded that the diving affects the seabed differently according to the species that can be found and the depth.

Adifferent regulation model is implemented changing the frequentation of the Medes Islands, passing from a homogeneous vision with daily regulation to a differentiated treatment of each dive zone in function of the type of the seabed and the fragility of the communities and species that live there, regulating the amount of simultaneous dives plus a yearly limit for each zone, with a system of annual reviewing in accordance to the results of the monitoring of the biological indicators.

How are the number established? The amount of dives authorized per year is the sum of the frequentation allowed at every buoy according to the realized studies.
